

**City of Walnut  
City Council Meeting  
January 11<sup>th</sup>, 2021, 7:00 P.M.**

**Call to Order**

Mayor Karen Crapson called the meeting to order with Council Members Brian Kirkpatrick, Brian Crapson, Jamie Burke, Joshua Sturm, and Cory Scott, all in attendance. Also in attendance were City Clerk Saralyn Boyd, City Treasurer Samantha Guy, City Superintendent Craig Kirkpatrick, and City Attorney Timothy Fielder.

**Approval of Agenda**

Brian Kirkpatrick made a motion to approve the meeting agenda. Brian Crapson seconded the motion. All were in favor.

**Approval of Minutes**

Brian Kirkpatrick motioned for approval of the minutes from the previous regular meeting. Jamie Burke seconded the motion. All were in favor.

**Approval of Bills**

**Clerk's Report**

The account balance as of January 11th, is \$64,073.16. As for delinquent utility accounts for December, all were paid in full. The number of utility bills left for December collection was reported at five accounts at the time.

City Treasurer, Samantha Guy, reported all was accurate for the reports for December.

**Old Business**

Mayor Karen Crapson reported a meeting was scheduled for Wednesday with Rusty at the Crawford County Emergency Department concerning the official ID's.

**New Business**

Paul Norris with Heartland Electric presented to the council information on the new street lights being installed throughout the town along with new billing information. The council did not request any changes to the current plan of action for these updates.

**Maintenance Report**

Craig mentioned the Tractor was in need of the initial 50-hour service. Craig & Brian Kirkpatrick were to arrange the delivery of the tractor to be serviced at R&F Farm Supply.

Interest in a dump truck that was for sale was mentioned, and further information was requested before any decisions were made.

Water Station Repairs are still in progress. Craig Kirkpatrick, Brian Kirkpatrick, and Brian Crapson are still working on setting up a date and time with cooperating weather for the welding that is needed on the pipe at the Maintenance Building/Water Station.

**Librarian's Report**

Pancake Feed is scheduled for January 16th, during 8-10 AM.

Librarian Sierra Kirkpatrick mentioned the \$120 check was presented from the Library to the City for the annual extra cost for the internet upgrade that was motioned for in the previous meeting.

Sierra stated the AC Pressure switch needed replaced at the Library and the Library took care of the estimated \$500 bill for the service.
