Payment Schedule: Net 30. **Must** submit a detailed bill including mowing dates to City Clerk by the end of each month.

Description of Services Required: Mowing, string trimming, litter and limb collection, including removal from premises, for the locations listed below.

### Locations of Properties:

1. Walnut City Park
2. City Hall and School/Library Park (this will include the entire block)
3. Corner of Main and Burns St. (commonly called Mike Fox Memorial Park)
4. Historic Gas Station located on Main St.
5. Perimeter around old fire station (city maintenance building)
6. Vacant lots on the SW corner of Main St. and Miller St.
7. City Hall located at 210 S. Main St.
8. City Storage Barn located at Locust & Elmwood St.

If you are a new bidder and have been awarded the bid, please set up an appointment with the Mayor to view and discuss all properties, including property lines, viewing of mowing obstructions, etc.

### Requirements to consider:

1. This bid is good for the 2026 mowing season.
2. Bidders must be 18 years or older. Bidders are responsible for the actions and/or any damages that may result caused by the bidder and of those assisting the bidder(s) in performing bid service duties.
3. Bidders shall carry liability insurance in the amount of not less than \$250, naming the City of Walnut as an additional insurer. Proof of insurance must be provided.
4. The City requires mowing and clean up of all properties to be specifically completed during the week before Labor Day weekend due to the Walnut Days celebration that weekend. Please prepare work accordingly and timely for this expected event.
5. The city reserves the right to terminate awarded bidders at any time without notice.
